We have also been considering the possibilities of what TWP can and should look like in the future – hitting at the very core of what inclusive development itself can and should look like in the shift [from programs to progress](#), and from international to locally-led development. We are honored to welcome you and this distinguished group of practitioners, thinkers, reformers and change agents to discuss all these questions and more over the course of this two-day symposium.

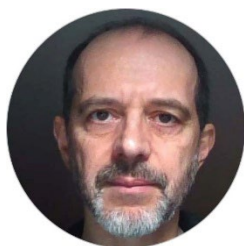
