1. Section I.1. Introduction

I.1. Introduction

Chemonics, the Buyer, acting on behalf of the U.S. Agency for International Development (USAID) and the Global Health Supply Chain Program-Procurement and Supply Management (GHSC-PSM) under prime contract number AID-OAA-I-15-00004, task order AID-OAA-TO-15-00009 is soliciting offers from companies and organizations to submit proposals to participate with GHSC-PSM to carry out support and maintenance of the Procurement Planning and Monitoring Report for malaria (PPMRm).

GHSC-PSM is the primary vehicle through which the U.S. Agency for International Development (USAID) procures and provides health commodities for countries receiving U.S. government foreign assistance. GHSC-PSM also provides technical assistance to improve the efficiency, reach, and sustainability of incountry supply chains and its funding includes the U.S. President's Malaria Initiative, currently managed under Malaria Task Order (TO2).

The PPMRm provides data on stock availability for critical malaria commodities. Data are used by the President's Malaria Initiative to highlight and address needs and potential supply challenges, including stockout situations. The objective of this acquisition is to seek for technical support of the PPMRm system throughout its operational phase.

Offerors are invited to submit proposals in response to this RFP in accordance with **Section I Instructions to Offerors**, which will not be part of the subcontract. The instructions are intended to assist interested Offerors in the preparation of their offer. Any resulting subcontract will be guided by Sections II and III.

This RFP does not obligate Chemonics to execute a subcontract nor does it commit Chemonics to pay any costs incurred in the preparation and submission of the proposals. Furthermore, Chemonics reserves the right to reject any and all offers, if such action is considered to be in the best interest of Chemonics.

Unless otherwise stated, the periods named in the RFP shall be consecutive calendar days.

**Written Questions and Clarifications.** All questions or clarifications regarding this RFP must be in writing and submitted to Natacia Mpanga, PSMProgramMgmtOps@chemonics.com, no later than 5:30 pm EST on December 7, 2022. Questions and requests for clarification, and the responses thereto, will be circulated to all RFP recipients who have indicated an interest in this RFP.

Only written answers from Chemonics will be considered official and carry weight in the RFP process and subsequent evaluation. Any answers received outside the official channel, whether received verbally or in writing, from employees or representatives of Chemonics International, the GHSC-PSM project, or any other party, will not be considered official responses regarding this RFP.

**Proposal Submission Date.** All proposals must be received by the date and time and complying with the instructions as provided in Section I.3.

**Oral Presentations.** Chemonics reserves the option to have select offerors participate in oral presentations with the technical evaluation committee. Interviews may consist of oral presentations of offerors' proposed activities and approaches. Offerors should be prepared to give presentations to the technical evaluation committee within 2 days of receiving notification.

**Subcontract Award (estimated).** Chemonics will select the proposal that offers the best value based upon the evaluation criteria stated in this RFP

Offerors are responsible for ensuring that their offers are received in accordance with the instructions stated herein. Late offers may be considered at the discretion of Chemonics. Chemonics cannot guarantee that late offers will be considered.

Proposals must be submitted electronically only. Late offers will be considered at the discretion of Chemonics.

Separate technical and cost proposals must be submitted by email no later than the time and date specified in I.2. The proposals must be submitted to the point of contact designated in I.2.

The Offeror must submit the proposal electronically with up to 3 attachments (5 MB limit) per email compatible with MS Word, MS Excel, readable format, or Adobe Portable Document (PDF) format in a Microsoft XP environment. Offerors must not submit zipped files. Those pages requiring original manual signatures should be scanned and sent in PDF format as an email attachment or signed by using e-signatures.

Technical proposals must not make reference to pricing data in order that the technical evaluation may be made strictly on the basis of technical merit.

#### 4. Section II.1. Background

**Delete in its entirety and replace with the following:**

GHSC-PSM is ensuring an uninterrupted supply of health commodities to prevent suffering, save lives, and create a brighter future for families across the globe. The GHSC-PSM indefinite delivery/indefinite quantity (IDIQ) contract has four TOs that directly support the President's Emergency Plan for AIDS Relief (PEPFAR), the President's Malaria Initiative (PMI), Population and Reproductive Health (PRH) and the Office of Maternal and Child Health and Nutrition through an array of services for health commodity procurement and related systems strengthening technical assistance encompassing the different elements of a comprehensive supply chain. Under the IDIQ, the Malaria Task Order (TO2) provides USAID missions, bureaus, and operating units with a worldwide mechanism to support PMI's goals to reduce malaria deaths and substantially decrease malaria morbidity toward the long-term goal of elimination.

The PPMRm provides data on stock availability for critical malaria commodities: artemisinin-based combination therapies (ACTs); sulfadoxine-pyrimethamine (SP) for intermittent preventive treatment during pregnancy; rapid diagnostic tests (RDTs) for accurate malaria diagnosis, artesunate injectables and artesunate suppositories for severe malaria treatment. The report describes stock status of anti-malarial products on a country-by-country basis and is produced monthly. Data collection is provided by USAID partners, including the Global Health Supply Chain Program and country bilateral projects.

The PPMRm was first piloted in 2008 in 10 countries in sub-Saharan Africa. As of 2021, 29 countries in Africa and Asia regularly report in the PPMRm. Data are used by the President's Malaria Initiative to highlight and address needs and potential supply challenges, including
