To measure standard lead time, PASCO will compare the time of departure from a ZAMMSA dispatch bay to the time of goods received as verified by an authorized representative of an SDP. PASCO will measure these timestamps primarily through a register signed by ZAMMSA, the vendor, and the receiving SDP. In cases where a register is not used, PASCO will use manual PODs (see definition above). In cases where data has been omitted from a register or POD, PASCO will consult ZAMMSA and verify the data via email. In the medium to long term, PASCO will work with ZAMMSA and the DeliveryExpert funding entity to incorporate these data elements into ePODs. The data source would thereafter be DeliveryExpert system data.
