2	Grants	This is to inquire about the total budget for the project and number of years of projects implementation.	<p>As per section II of the concept note on the award information, CBCR anticipates awarding two LDOs in each cluster of Karamoja, Mandera, and Moyale; with each grant award being USD 90,000 equivalent to the local currency, but the final amount will be dependent upon grant activities and final negotiation and may be lower or higher the amount stated.</p> <p>The duration of any grant award under this solicitation is expected to be no more than one year.</p>
3	Grants	Does the \$90,000 budget allocation apply to a single-area proposal, such as the Dollo area? Is this \$90,000 inclusive of both program and support costs?	<p>Like question two above under section II, CBCR anticipates awarding a total of two LDO in each cluster, with each LDO grant award being USD 90,000 equivalent to the local currency.</p> <p>The USD 90,000 is inclusive of both programmatic and support cost as outlined in the budget template.</p>
4	Grants	What is the recommended ratio between program costs and support costs?	<p>CBCR expects each partner to ensure that the programmatic activity costs to carry a bigger percentage of the overall budget. However, following the selection of the partner CBCR will have further negotiations to streamline the costs.</p>
5	Grants	Is it a mandatory requirement for organizations to apply in consortium or can they apply individually for a specific location provided they fit within the targeted corridor e.g. only cross border	<p>No, it is not expected for applicants to apply as a consortium. Under this Concept Note CBCR expects each applicant to submit individual concept notes targeting in-country activities in corridors within Karamoja, Mandera, and Moyale clusters with high prevalence of Gender Based</p>

As per section III of the Concept Note, bullet number nine: Applicants may only submit one application per organization under this Concept Note.
7	Technical/Grants	Are activities such as the purchase and installation of solar streetlights, or the repair of malfunctioning solar streetlights in IDP areas where they are already installed, eligible under this grant if they are directly linked to the prevention of GBV incidents in respective IDP/Township locations?	As per section IVA2 Ineligible expenses bullet one, CBCR grant funds may not be utilized for construction or infrastructure activities. The proposed activity in the question falls under these two categories, as such CBCR grant funds may not be utilised for such.
8	Technical	Is integrating training of GBV survivors on economic empowerment skills particularly dress making, beauty therapy and hair dressing and provision of start-up kits for sustainability of this activity allowed under this grant?	Yes, CBCR expects potential applicants to provide such and other innovative livelihood activities for GBV survivors.
